

**CORRECTION OF ERRORS**  
**INVESTIGA@UIB PROGRAMME**  
**SUBPROGRAMME TO PROMOTE DOCTORAL TRAINING (PREDOCS)**

**PROMOTING PRE-DOCTORAL TRAINING UNDER JOINT SUPERVISION WITH  
RENOWNED INTERNATIONAL UNIVERSITIES – INTERNATIONAL PREDOCS**

In relation to the Resolution of 1 September 2025 of the University of the Balearic Islands, which announces the subprogramme for the promotion of doctoral training (PREDOCS) to support pre-doctoral training under joint supervision with renowned international universities – INTERNATIONAL PREDOCS, certain errors have been detected that need to be corrected.

The following amendments are issued:

In section III.7.b), where it states:

For the purposes of aligning the effective period of the grant and academic years, each academic year shall run from 1<sup>st</sup> October in the relevant year to 31<sup>st</sup> July the following year, both inclusive. The above notwithstanding, tuition fees for the 2025-26 academic year shall be covered by the grant, regardless of its effective period with regard to pre-doctoral activity and recruitment.

It should state:

Regardless of the date of award of the grants and the date of commencement of the contract, the tuition fees for doctoral studies corresponding to the 2025–2026 academic year shall be considered an eligible expense chargeable to the travel and installation grant provided for in section V.1.b), in whole or in part. The applicant must indicate in the application the estimated amount of tuition fees (UIB and foreign university) and provide a coverage plan detailing all the expected sources of funding – personal contributions, contributions from the host structure at the UIB (group, consolidated group, institute or unit), contributions from the host structure at the foreign university– and, where appropriate, the need for co-funding by the Vice-Rectorate for Scientific Policy and Research for its assessment.

In section V, where it states:

4. The award of grants set out in this resolution is subject to budget availability.

It should state:

4. By way of exception, and only to cover doctoral tuition fees during the term of the grant, the overall amount of the grant provided for in section V.1.b) may exceed €3,000, strictly in the necessary amount, taking into account the co-funding plan provided for in section III.7.b), the strategic interest of the action, and the budgetary availability. As a guideline, the grant allocated to tuition fees awarded under this programme shall not exceed 50% of the total cost of tuition fees at both institutions

And the following is added:

5. The award of grants set out in this resolution is subject to budget availability.



In section VII.1, the following is added:

h) Document indicating the estimated amount of tuition fees (UIB and foreign university) and a coverage plan detailing all the expected sources of funding –personal contributions, contributions from the host structure at the UIB (group, consolidated group, institute or unit), contributions from the host structure at the foreign university– and, where appropriate, the need for co-funding by the Vice-Rectorate for Scientific Policy and Research for its assessment.

This correction of errors and all administrative steps arising from it may be appealed in the form and manner set out in Act 39/2015 of 1st October on the Common Administrative Procedure for Public Administrations.
